You must respond **WITHIN 10 DAYS** (See 28 U.S.C. § 1864).

Your name was randomly selected from voter and driver/state ID records to complete a questionnaire to determine your *eligibility* for federal jury service. As jury rolls are refreshed every two years, those deemed qualified *could* be chosen at random to receive a federal jury summons through 2027. **THIS IS NOT A SUMMONS TO APPEAR.**

To help us be efficient, please complete your questionnaire in **eJuror**, which is accessible from the **Jurors** page of our website. Focus your smartphone camera on the QR code on the reverse and click the link that pops up, or go to: www.txed.uscourts.gov and click "Jurors." The **Jurors** page details how **eJuror** protects your data, gives guidance on avoiding and reporting jury scams to law enforcement, provides a link to a sample of this postcard for your verification purposes, and includes numerous links to respond to your juror qualification questionnaire in **eJuror**. The same paragraph on postcards sent to residents in our Sherman and Tyler divisions read: "Call (866) 291-6747 to request a paper questionnaire, claim your right to immediate excuse if you are over age 70, or receive assistance. We are honored to serve you."
