GENERAL ORDER REGARDING TRANSCRIPT RATES

At its September 2022 session, the Judicial Conference of the United States approved an increase to the maximum per page original and copy transcript fees, effective October 1, 2023. The increase of roughly ten percent in each of the fiscal years 2024 and 2025, or roughly 20 percent overall, is aimed at keeping pace with inflation and helping courts recruit and retain qualified court reporters.

It is hereby **ORDERED** that pursuant to 28 U.S. Code § 753, the original and copy transcript fees per page for civil and criminal cases, as approved by the Judicial Conference, are adopted by this Court and will be effective on October 1 of each fiscal year as indicated in Attachment A.

This order supersedes General Order 07-08.
