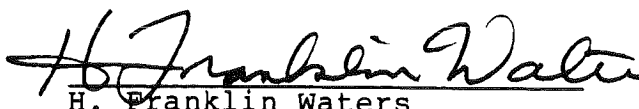
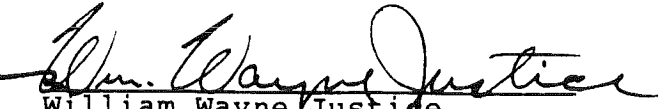

1985.

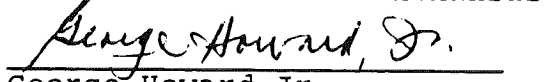
 

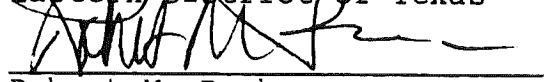
