## 86-4 Reappointment of Part-time Magistrate

The term of office of the Honorable Roger D. Sanders, part-time United States Magistrate for the Sherman Division, Eastern District of Texas, being due to expire on February 14, 1986, and

The Judicial Conference of the United States, having voted to continue the part-time magistrate position at Sherman for an additional four-year term of office,

In accordance with the 1979 amendments to the Federal Magistrates Act, 28 U.S.C. Section 631, et sequi, and the 1980 regulations of the Judicial Conference, promulgated under authority of 28 U.S.C. Section 631 (b)(5), a Notice of Appointment of Panel to Consider Reappointment of United States Magistrate was published, a panel of citizens to consider the reappointment of Magistrate Roger D. Sanders was appointed by General Order of the Court dated December 13, 1985, and

The panel met, reviewed the incumbent's current service as magistrate, invited comments from members of the bar and public and other evidence of the incumbent's good character, ability and commitment to equal justice under the law and reported to the Court, unreservedly recommending the reappointment of Roger D. Sanders as part-time United States Magistrate.

WHEREFORE, in accordance with the authority conferred by 28 U.S.C. Section 631, et sequi, and the further authority granted and action taken by the Judicial Conference of the United States in its 1980 regulations, it is hereby

ORDERED that the Honorable Roger D. Sanders of Sherman,
Texas, is hereby reappointed part-time United States Magistrate
at the salary as fixed by the Judicial Conference of the United
States, with his official station being Sherman, Texas.

Roger D. Sanders shall enter upon the performance of his duties at 12:01 a.m. on February 15, 1986, but prior to the commencement of such duties shall take the oath or affirmation prescribed by sections 453 and 631 (f) of Title 28, U.S.C. He shall serve as part-time United States Magistrate and discharge the duties of said office for a term of four (4) years from February 15, 1986, unless sooner removed, subject to the provisions of section 631 (c) of Title 28 U.S.C.

All General Orders heretofore entered and not rescinded by the Court conferring powers and duties upon the Magistrate shall be in full force and effect and are adopted herein.
