ORDER

Due to the Courts' concern for consistent and efficient case management of the numerous asbestos related claims filed in the Eastern District of Texas, **IT IS HEREBY ORDERED ADJUDGED AND DECREED THAT** counsel for all interested parties in asbestos cases pending in the Eastern District of Texas appear before the United States District Courts, sitting **en banc** at the United States Courthouse, Tyler, Texas on **Friday, July 29, 1988, at 11 AM.**, to consider the following issues:

1. Whether an Alternate Dispute Resolution (ADR) procedure should continue to be utilized as a method of asbestos case management in the Eastern District of Texas¹;


2. Whether to certify and proceed with a second "Jenkins type" class action in all of the remaining unadjudicated asbestos cases within the Eastern District;

¹ The Court is also interested in discussing the particular **format** of any future Alternative Dispute Resolution procedure.

3. Whether to modify the Honorable Robert M. Parker's September 1, 1987, May 25, 1988, and June 17, 1988 orders (finding a lack of good faith participation by certain parties; cases removed from the ADR process and placed on the regular dockets of judges throughout the district); and

4. Whether any other suggested alternatives could adequately and efficiently adjudicate the numerous asbestos related claims in the district.
