ORDER ON REMOVAL OF CASES FROM STATE COURT TO FEDERAL COURT

It has come to the attention of this Court that certain pleadings filed of record in state court during the pendency of the case in that court are essential to the production and maintenance of automated docket records of the federal court. It is therefore,

ORDERED that parties removing their case from state court to federal court furnish to the Clerk of Court of the U. S. District Court, Eastern District of Texas, at the time of filing of their notice of removal, a certified copy of the state court docket sheet; a completed Civil Cover Sheet that accurately describes the case being removed, and which reflects the style of case exactly as it was styled in the state court; and a copy of all process, pleadings, and orders served upon the party removing the case to this Court, as required by 28 U.S.C. §1446(a).

It is further ORDERED, pursuant to 28 U.S.C. §1448(b) that the party or parties removing the case furnish to the Clerk of Court of the U.S. District Court the following information within ten days from the date of removal of the case to this Court:

(1) A list of all parties in the case, their party type (plaintiff, defendant, intervenor, receiver, etc.) and current status (pending, dismissed).

- (2) A copy of all pleadings that assert causes of action (e.g., complaints, amended complaints, supplemental complaints, petitions, counter-claims, cross-actions, third-party actions, interventions, etc.) and all answers to such pleadings
- (3) A complete list of attorneys involved in the action being removed, and each attorney's bar number, address, telephone number and party or parties represented by him/her
 - (4) A copy of all executed service of process
 - (5) A record of which parties have requested trial by jury
 - (6) A copy of all pending motions and responses thereto.

Failure to comply with the requirements set forth in this Order may result in dismissal of the case.
