AMENDED ORDER ASSIGNING CIVIL AND CRIMINAL ACTIONS

In accordance with Title 28, United States Code, Section 137 and the agreement of the judges affected hereby, it is

ORDERED that, effective May 20, 1992, all civil and criminal actions then pending in the Paris and Lufkin divisions of the district, as well as civil and criminal actions which are thereafter filed in such divisions, shall be, and they are hereby, assigned to the individual judges of this district in the proportions listed below, respectively:



This order amends General Order Number 90-8, Amended Order Assigning Civil and Criminal Actions, dated May 14, 1990. Changes effected by this amendment include the reassignment of all Paris Division cases from the docket of Judge Paul Brown to the docket of Judge William Wayne Justice (see exhibit A); and the

reassignment of Judge Justice's former portion of the Lufkin Division cases to Chief Judge Robert M. Parker (see exhibit B).

It is further ORDERED that any cases re-opened on or after May 20, 1992, shall be re-opened to the docket of the judge to whom the case was assigned at the time of closing.
